Working languages: Ukrainian, English.

THE WORK ORDER OF THE SEMINAR:

Plenary presentations: up to 20 minutes, additional 10 minutes for discussion

Presentations in sections: up to 10 minutes, additional 5 minutes for discussion

The order of seminar, code and meeting ID for the ZOOM platform will be sent to participants on October 10, 2024, at the e-mail addresses indicated in the registration form.

The seminar's work will be covered by broadcasting the event on the Internet resources of the organiser and partners of the event. The seminar proceedings will be available for download to various interested parties.

There is no organisational fee associated with attending the seminar.**

Publication of reports is free of charge
The volume of materials for printing up to 5 pages that are not numbered

THE ORDER OF SENDING MATERIALS BY EMAIL

The Latin file name should match the conference participant's name and surname (e.g., mulenko_m.doc)
The text was created in Microsoft Word and then saved using the *.doc extension.
The email's subject field should include the participant's name and surname, followed by the phrase 'For a scientific and practical seminar'.

REQUIREMENTS FOR THE DESIGN OF MATERIALS FOR THE PRINTING

Microsoft Word must be used to enter the report's text, which can be up to 5 pages in A4 format.
The order in which structural elements are presented in reports:
The first and last name of the author (s), the line below: the organisation, where the author/authors work, and e-mail address. For all this information we are entering bold font, TimesNewRoman font, pin 12, centre alignment;
through the line - the name of the report (bold, font TimesNewRoman, pin 14, in all large letters, centre alignment);
through the line after the name - summary and keywords (Times New Roman font, pin 12, width alignment);
through line - main text (TimesNewRoman font, pin 14, width alignment);
One line after the main text, the sources and literature used are given in Times New Roman font with pin 12, width alignment.

TEXT is presented without subheading individual sections (unless necessary). Individual structural elements of the text are highlighted with an empty line.

Page settings: left, top, bottom field - 2 cm, right - 1 cm; Paragraph indentation - 1cm, single line spacing.

HISTORY OF CREATION OF THE GENERAL GEOLOGICAL RESERVE OF NATIONAL IMPORTANCE "DNIPROVSKI POROGY"

SUMMARY

KEYWORDS:

The state geological reserve of national importance ‘Dniprovski porogy’ was established according to the Resolution of the Council of Ministers of the Ukrainian SSR dated October 28, 1974, No. 500. The reserve includes Khortytsia Island, except for the gardens and fields of the State Agricultural Enterprise ‘Khortytsia,’ Baida Island, the Three Stohy cliffs, Dubovy Island, and the Two Braty cliffs. This territory belongs to the Natural Reserve Fund of Ukraine and is protected as a national heritage, subject to special conservation, reproduction, and use regulations.
